## T W Woods Construction Level 2 Energy Audit CTIP Application and ongoing reporting

The owners of this manufacturing site were very keen to reduce their energy usage and cost to improve their competitiveness in the market as demand for their services decreased due to economic downturn.

JCM, through the NSW Office of Environment and Heritage (OEH) Energy Saver Program, provided a Level 2 Energy Audit to identify opportunities for reducing energy demand on site.

Analysis of the energy use patterns on site identified that the compressed air system used the vast majority of energy on site, with lighting and ventilation also providing significant opportunities for energy efficiency



JCM recommended that the site upgrade their

ageing air compressors to new variable speed compressors with better control logic that would more effectively cope with the variable air demand on site. The site also increased their use of natural light through the installation of translucent panels on the workshops, reducing their dependence on high bay lighting. the compressed air system was also upgraded to reduce leaks and the operation of the ventilation system streamlined.

To assist with the funding of these measures, the company decided to apply for a federal government grant through the Clean Technology Investment Program (CTIP). JCM helped the company to successfully apply for the grant and to prepare the ongoing milestone reports. JCM also assisted the company in receiving the maximum funding available when the scope of works was changed during implementation.



Since the implementation of these measures, the electricity intensity on site has <u>decreased by over</u> <u>40%.</u>
